Assessment Method

Phone Call

- ▶ (1) Who is the Title IX Coordinator?
- ▶ (2) Where can a student go on campus to report a sexual misconduct?
- ▶ (3) Who are mandatory reporters?
- ▶ (4) To whom could a student (confidentially) report a sexual assault?
- ▶ (5) Are there sexual assault awareness and prevention resources on campus?

Website

- ▶ How many clicks did it take to get to a site with information about sexual assault?
- ▶ Was there a way to report sexual assault online?

Findings

- ▶ Inconsistent information across campuses on where to report
- ▶ Mandatory reporting for almost all faculty
- ▶ Limited information on resources for victims or non-mandatory reporters (including inaccurate information about who is and is not a mandated reporter)
- ▶ Title IX Websites are difficult to navigate to access resources/reporting information
- ▶ Difficult to get in touch with Title IX coordinators (10/14 or 70% response rate)
- ▶ Only a few school with access to a working online reporting link (5/14 or 36%)
